**ORDER TERMINATING DISCIPLINARY PROCEEDING**

The New Hampshire Board of Nursing (“Board”) first granted Linda Carter (“Ms. Carter or Respondent”) a license to practice as a Registered Nurse on April 30, 1992, and a license to practice as an Advanced Practice Registered Nurse (“APRN”) on October 15, 2019. Ms. Carter was issued license numbers 03699-21 (RN) and 03699-23 (APRN).

On September 22, 2022, the Board issued an emergency suspension of Ms. Carter’s license to practice as a RN and APRN in the state of New Hampshire Based on a suspension of Ms. Carter’s license to practice in the Commonwealth of Massachusetts on or about June 9, 2022. On September 28, 2022, Ms. Carter entered into a *Voluntary Preliminary Agreement Not to Practice* with the Board waiving an emergency suspension hearing. The Board approved the *Voluntary Preliminary Agreement Not to Practice* on September 29, 2022. In matters where an emergency suspension hearing is

waived, a full evidentiary hearing is required to complete adjudication unless the matter is resolved informally.

On June 14, 2023, the Board and Ms. Carter entered into a Confidential Non-Disciplinary Remedial Action Agreement (“ Agreement”) pursuant to RSA 310-A:1-k, VIII (effective January 1, 2022 to July 14, 2023) which resolved the above captioned matter. Pursuant to RSA 310-A:1-k, VIII., all proceedings for non-disciplinary remedial action shall be exempt from the provisions of RSA 91-A, except that the Board *may* disclose any final action that affects the status of a license, including any non-disciplinary restrictions imposed.

The Agreement authorizes Ms. Carter to return to practice as a RN and APRN in the State of New Hampshire with full privileges including the privilege to prescribe medications. The Agreement supersedes the *Voluntary* Preliminary Agreement Not to Practice dated September 29, 2022 and as such the *Voluntarily* Preliminary Agreement Not to Practice is no longer in place. The Agreement became effective June 14, 2023.
